**Re: An Important Update from Globe - Deferment in Change of Legal Entity**

Dear Valued Customer,

We recently wrote to you on the impending change to the way we operate with the consolidation of our operating subsidiary companies under our parent entity, Australian Agribusiness (Holdings) Pty Ltd.

We have today made the decision to **further defer this change**, originally scheduled for the 21st January 2023, **until 20th March 2023**.

This decision has been made to ensure we are able to have the smoothest possible transition whilst continuing to provide the best possible, uninterrupted service to you, our customer throughout the transition.
